THE HIRER WILL BE LIABLE FOR ANY DAMAGE TO THE HALL, FURNITURE, FITTINGS, EQUIPMENT AND THE SURROUNDING GARDENS.

CHARGES AND PAYMENT

MONDAY-FRIDAY- £12 PER HOUR OR PART THEREOF SATURDAY, SUNDAY AND BANK HOLIDAYS - £15 PER HOUR OR PART THEREOF

ALL MONIES TO BE PAID BY BANK TRANSFER

ALL REGULAR BOOKINGS MUST BE PAID 1 MONTH IN ADVANCE

HALL RESTRICTIONS

A MAXIMUM ATTENDANCE OF 70 PEOPLE

ALL MUSIC MUST CEASE AT 22:00 HOURS

ON SATURDAYS THE PREMISES TOTALLY VACATED BY 23:00
ON SUNDAYS AND WEEKDAYS THE HALL MUST BE TOTALLY VACATED BY 22:00

FUNCTIONS FOR PERSONS BETWEEN THE AGE OF 12 TO 21 YEARS ARE NOT PERMITTED.

NO PYROTECHNICS, FIREARMS, OR SPECIAL EFFECTS TO BE USED IN THE HALL

BOUNCY CASTLES ARE RESTRICTED TO SMALL AS THE CEILING IS ONLY 8 ft HIGH

ALCOHOL IS NOT TO BE SOLD WITHOUT THE RELEVANT LICENCE

HALL REQUIREMENTS DURING HIRE

THE HALL MUST BE LEFT IN A CLEAN AND TIDY STATE ON COMPLETION OF THE HIRE THIS INCLUDES:

- REMOVING ALL RUBBISH FROM THE PREMISES.
- TABLES AND CHAIRS ARE CLEANED BEFORE RESTACKING
- NO NAILS OR TACKS ARE TO BE DRIVEN INTO THE WALLS, DOORS, WINDOW FRAMES, OR CEILING ETC. ONLY "BLUE -TACK" OR SIMILAR PRODUCTS MAY BE USED. NOTHING TO BE FIXED TO CEILING.

HIRERS OF THE HALL SHOULD HAVE THEIR OWN PUBLIC LIABILITY INSURANCE
